Message from President Judge Clark - To the District Attorney's Office and Defense Bar

Given the recent increase in positive COVID-19 cases, the District Attorney's Office and the criminal defense bar have expressed interest in conducting as many court hearings as possible through videoconferencing. After consultation with the Criminal Division Judges, it has been determined that from July 8th through July 17th, the following will occur:

- 1. Many, if not all, of the ADAs will participate in court events only through Microsoft Teams. Defense counsel is also strongly encouraged to participate in proceedings through Teams. However, you and your clients as well as witnesses will still be able to come into the Courthouse in-person for court proceedings. The Allegheny County Courthouse will be open to the public as normal, but every effort will be made to conduct as many proceedings as possible through videoconferencing.
- 2. I have asked the judges to utilize Teams whenever possible to conduct court proceedings in whole or in part, consistent with the confrontation clause, recognizing that there may be situations where it is not feasible to conduct a proceeding or an entire proceeding through Teams.
- 3. I have also asked the judges during this week and next week to liberally grant motions for continuance from both the Commonwealth and the defense, particularly in cases where the use of videoconferencing is not feasible.

The goal during this period of time is not only to reduce traffic in the Courthouse and to give the Court time to further assess the situation in the COVID-19 Criminal Division but also to force us all to get comfortable with remote hearings. This may be our "new normal" in that it is unclear how this pandemic will develop. A very large portion of criminal cases are pleas which can easily be done remotely.

I would ask that you do the following:

- Please practice using the Microsoft Teams to become comfortable with remote hearings.
- · Please make sure that you speak with your client, witnesses and opposing counsel before coming to the courthouse and participate in a meaningful Case Status Conference as ordered by the Administrative Judge. By doing this, you can enter into plea agreements prior to the date of trial and witnesses can be called off or participate remotely. Cases may also be postponed online in advance, reducing the number of people in the courthouse and reducing the need for face-face contact.
- Consider entering into stipulations for facts not in dispute.

and cooperative with each other during this difficult transition.

- You should strongly discourage your clients and witnesses from bringing an "entourage" to any in-person hearings.
- · Help us maintain safety by ensuring that your clients and witnesses wear their masks and social distance
- · Defense attorneys should speak with their clients about the benefits of holding the hearing, in whole or in part, remotely. Microsoft has tutorial videos on its website showing how to use Teams and demonstrating its capabilities.

We understand that many of us are not ready to make such a quick transition to primarily remote hearings. Unfortunately, our current situation mandates such a change and we cannot wait until we are all ready. We need to start, learn from our mistakes and try to do better each day. I ask all of us in the criminal justice system to be patient

Order of the Secretary of Health **Requiring Universal Face Coverings**

To: All President Judges and District Court Administrators

As we advised last week, the Secretary of Health on July 1, 2020, issued an Order requiring all individuals (subject to limited exceptions) to wear face coverings when interacting with others outside their household. See https://bit.ly/3glpiyp.

Since we issued our advisory, AOPC has received several inquiries about the application of the Secretary's Order to courts and courthouses. Unlike previous orders, there are no general exceptions in the Secretary's Order for local governments or other government entities, including counties and courts. In fact, the Department of Health (DOH) on July 3 posted on its website an FAQ that states explicitly that the Secretary's Order applies to individuals "inside and outside of local government facilities, court houses, and other government buildings." See https://bit.ly/3gEbUeE (bolding added).

The Secretary of Health issued the Order under authority granted to her by Section 5 of the Disease Prevention and Control Law of 1955 (35 P.S. § 521.5), Sections 2102(a) and 2106 of The Administrative Code of 1929 (71 P.S. §§ 532(a) and 536), and DOH regulations at 28 Pa. Code §§ 27.60-.68. In the interest of public health and safety, and in light of recent reports of transmission within court houses, AOPC strongly recommends adherence to the Secretary's Order, including inside courtrooms.

Of course, compliance with the Secretary's Order in a manner consistent with the needs of a judicial proceeding necessarily requires that courts and judges exercise judgment and discretion. For example, the mandate to wear face coverings can be implemented and enforced only in such manner that enables those who are required to speak (e.g., attorneys. witnesses, the judge) to do so intelligibly and effectively. In addition to social distancing, a court also might consider forms of face coverings (face shields) or other measures (such as transparent barriers) that simultaneously facilitate effective communication and personal protection of all in the courtroom.

Non-Contact Attorney Visits at the Allegheny County Jail COVID-19 Information

Effective Wednesday, July 8, 2020, the Allegheny County Jail will allow attorney visits to the facility.

For the foreseeable future, attorney visits will take place between 9 a.m. and 5 p.m., 7 days a week on the M Levels. Inmates will not be available from 10:45 a.m. to 11:30 a.m. or 2:45 p.m. to 3:15 p.m. due to necessary completion of institutional counts. Times are subject to change and additional closures may occur due to emergent circumstances.

On-site facility visits will permit attorneys to communicate with their clients in a non-contact setting. These visits will be conducted from behind glass in the designated visiting booths. This measure coincides with the physical-distancing practices the ACJ has had in place since March

Upon entrance into the facility, attorneys must provide their Bar card and identification. Additionally, all attorneys will be mandated to wear their own masks for the entirety of their visit, maintain a physical distance of six feet at all times, have their temperature taken and be under 99.0 degrees and answer the necessary screening questions to include the following:

- 1. Have you traveled outside of Pittsburgh within the past 2 weeks?
- 2. Have you had any contact with anyone displaying symptoms of COVID-19?
- 3. Have you experienced any symptoms of COVID-19 (i.e. shortness of breath, cough, fever, loss of smell, loss of taste, myalgia (muscle pain), fatigue, nausea, diarrhea) since your last screening?

If an attorneys is unable to wear a mask because of their own health restrictions or unable to pass the screening measures, they will not be permitted entry for that date, but still may be accommodated through the Allegheny County Jail's Video Arraignment department.

Attorneys will be responsible for cleaning the phone and commonly touched areas of the visiting booth with cleaning products provided by the ACJ. Failure to follow these guidelines could result in visitor privileges being revoked. Please anticipate delays in the process, as we continue to comply with the strict guidelines set forth by the Center for Disease Control (CDC), Pennsylvania Department of Health and Allegheny County Health Department.

County New Chapter 485. The Allegheny County Code of Ordinances, Chapter 475, entitled "Taxation," is hereby amended through the creation of a new Article XII, entitled "Sheriff's Sales," and comprised as follows: Article XII

Sheriff's Sales

§475-60. Recording of deeds and notification of Sheriff's sales to taxing bodies.

A.
