### NOTICE TO THE MEMBERS OF THE BAR ASSOCIATION ACBA BOARD OF GOVERNORS AMENDS BAR ASSOCIATION BY-LAWS

On Tuesday, April 6, 2021, the Board of Governors at its monthly meeting voted to amend the Bar Association By-Laws. A quorum of members of the Board was present for the Board Meeting. The vote of those present at the meeting to amend the By-Laws was unanimous.

In accordance with Article 21 of the ACBA By-Laws, the Board can amend the By-Laws by a vote of 2/3 of the members of the Board of Governors present and voting at any meeting in connection with which a quorum is present; provided that the results of the such vote shall be published in the Pittsburgh Legal Journal within ten (10) days of the aforesaid vote to amend, accompanied by a notice to members that the By-Laws, as amended, shall become effective within twenty (20) days of the date of such publication unless a petition is filed with the Association signed by fifty (50) active members in good standing requesting a vote of the membership on the subject amendment(s), or particular portion(s) thereof. Upon receipt of such petition, the matter shall be placed before the membership for a vote at the next annual meeting of the membership or at a meeting specially convened for that purpose.

Notice is hereby given that the By-Laws, as amended, shall become effective on April 30, 2021 unless a petition is filed with the Association as herein above set forth.

The following are the proposed amendments. The new language is underlined and shown in bold type and removed language is stricken out. A full and complete copy of the Bar Association By-Laws is available on the web site at www.acba.org under the "About" tab.

#### Article 2 Membership

Section 2.1. CLASSES.

The membership of the Association shall consist of active, associate, honorary members, affiliates, and law students Active, Associate, Affiliate, Emeritus Status, Honorary and Law Student Members. For the avoidance of doubt, membership does not confer a property interest on the member of the Association.

#### Section 2.4 EMERITUS STATUS MEMBERS

Any lawyer approved for emeritus status pursuant to Rule 403 of the Pennsylvania Rules of Disciplinary Enforcement shall be eligible for Emeritus Status Membership. Emeritus Status Members shall be entitled to Active Members' rights and privileges, except that the Emeritus Status Members shall not have the right to vote or to hold office in the Association. An Emeritus Status Member may serve as a voting member of any Committee, Division, or Section of the Association, except the Judiciary and Nominating Committees.

Section 2.8-2.9. APPLICATION FOR MEMBERSHIP.

Membership shall be open to all qualified applicants regardless of race, color, creed, ethnicity, national origin, religion, sex (gender), sexual orientation, gender identity or expression, genetic information, mental or physical disability, familial status, veteran status, or age. All applications for membership shall be signed and submitted by the applicant and addressed to the Membership Department at the offices of the Allegheny County Bar Association which shall forward such applications to the Board of Governors for action thereon. Applications for Active or Associate Membership Active, Associate, or Emeritus Status Membership shall contain evidence satisfactory to the Membership Department that the applicant is a member in good standing of the bar of a state, territory, or possession of the United States. Applications for law students shall contain evidence satisfactory to the Membership Department that the applicant is attending an ABA accredited law school. Approval of applicants for membership shall be by vote of the Board of Governors.

Article 3 Dues

Section 3.1. DUES FIXED BY BOARD OF GOVERNORS.

The annual dues of active, inactive, and associates members, affiliates Active, Associate, Emeritus Status, Honorary, Affiliate, and Law Student Members, and of any other class of members hereafter established, may be fixed annually by the Board of Governors. The Board of Governors may classify and divide any class of members by period of admission to practice, age, residence, location of office, occupation, or any reasonable standard of classification.
