c. The PACSES Case ID, if a complex support matter;

d. A copy of the fully-executed Order of Court referring the matter for scheduling before a DHO;

e. A copy of the fully-executed Order Approving Grounds (pursuant to Pa.R.C.P. 1920.42) if the case is being scheduled for an Equitable Distribution hearing;

f. Two (2) self-addressed envelopes, one for each counsel and/or pro se litigant;

g. Check(s) made payable to “Divorce Hearing Officer” (\$250 for 3-hour conciliations/hearings; \$500 for 6-hour conciliations and \$500/day for full-day hearings for the first two days of hearing; \$600/day for the third day of hearing and beyond).

3. **Scheduling will not occur until full payment for the proceeding has been received by the Divorce Hearing Office.** Once full payment has been received, the D.H.O. assigned to the case will email both counsel and/or pro se litigant(s) with available dates.
