NOTICE OF PROPOSED RULEMAKING

**Proposed Amendment of
Pa.R.Civ.P.M.D.J. 514, 515, 516, 521,
1005, 1006, 1007, 1008, 1011, 1013,
and 1014**

The Minor Court Rules Committee is considering proposing to the Supreme Court of Pennsylvania the amendment of Pa.R.Civ.P.M.D.J. 514, 515, 516, 521, 1005, 1006, 1007, 1008, 1011, 1013, and 1014. The proposal provides for the service of a reissued order for possession and notice, in certain instances, ten days prior to (1) the striking of an appeal or writ of certiorari or (2) the termination of a supersedeas, for the reasons set forth in the Publication Report.
