

On Tuesday, June 6, 2023, the Board of Governors at its monthly meeting voted to amend the Bar Association By-Laws. A quorum of members of the Board was present for the Board Meeting. The vote of those present at the meeting to amend the By-Laws was unanimous.

In accordance with Article 21 of the ACBA By-Laws, the Board can amend the By-Laws by a vote of 2/3 of the members of the Board of Governors present and voting at any meeting in connection with which a quorum is present; provided that the results of the such vote shall be published in *the Pittsburgh Legal Journal* within ten (10) days of the aforesaid vote to amend, accompanied by a notice to members that the By-Laws, as amended, shall become effective within twenty (20) days of the date of such publication unless a petition is filed with the Association signed by fifty (50) active members in good standing requesting a vote of the membership on the subject amendment(s), or particular portion(s) thereof. Upon receipt of such petition, the matter shall be placed before the membership for a vote at the next annual meeting of the membership or at a meeting specially convened for that purpose.

Notice is hereby given that the By-Laws, as amended, shall become effective on Thursday, June 27, 2023, unless a petition is filed with the Association as herein above set forth.

#### BY-LAWS OF THE ALLEGHENY COUNTY BAR ASSOCIATION

Section 1.3 DEFINITIONS

Division Board Member: The Chair or, if the Chair is already a member of the Board of Governors, the Chair-Elect of the Homer S. Brown Division during the year immediately following the Chair's election, the Chair or, if the Chair is already a member of the Board of Governors, the Chair-Elect of the Women in the Law Division during the year immediately following the Chair's election, the Chair and the Chair-Elect of the Young Lawyers Division during the year immediately following their elections, and the most recent Past-Chair of the Young Lawyers Division.

Ex Officio Board Member: The President Judge of the Allegheny County Court of Common Pleas, the Chief Judge of the United States District Court for the Western District of Pennsylvania, and the current Pennsylvania Bar Association Zone 12 Governor to the Pennsylvania Bar Association (PBA) House of Delegates.

Section 8.1. BOARD MEMBERSHIP

The Board of Governors shall consist of fifteen (15) elected Governors, five (5) of whom shall be elected each year for a three-year term from the Active Membership at the annual election of the Association, and shall be eligible for re-election for a consecutive second three-year term, together with the following: the President, the President, the Immediate Past-President, the Secretary, the Treasurer, the Chair or, if the Chair is already a member of the Board of Governors, the Chair Elect of the Homer S. Brown Division during the year immediately following the Chair's election, the Chair or, if the Chair is already a member of the Board of Governors, the Chair Elect of the Women in the Law Division during the year immediately following the Chair's election, the Chair and the Chair Elect of the Young Lawyers Division during the year immediately following their elections, and the most recent Past Chair of the Young Lawyers Division. five (5) Division Board Members and three (3) Ex Officio Board Members, which shall be voting positions. including the President Judge of the Allegheny County Court of Common Pleas, the Chief Judge of the United States District Court for the Western District of Pennsylvania,

and the current Pennsylvania Bar Association Zone 12 Governor to the Pennsylvania Bar Association (PBA) House of Delegates.

#### Section 8.5. MEETINGS.

- (a) The Board of Governors shall meet <u>monthly</u> at least quarterly at a date, time, and place within or without the Commonwealth of Pennsylvania, as determined from time to time by the Board of Governors <u>unless the meeting is canceled by the President of the Bar Association</u>. The President may <u>call for additional Board of Governors meetings</u>, provided that notice is given to the Board Members <u>prior to the meeting</u>. Unless otherwise provided in these By-Laws, Robert's Rules of Order, as updated from time to time, shall govern the conduct of business at all meetings.
- (b) At all meetings, the Board of Governors shall provide for electronic meetings through the use of technology that permits Board Members and other individuals invited to participate to have simultaneous aural communication, as if they were physically present in the room.
- (c) <u>All Board Members shall be expected to attend all meetings. The Secretary will record absences in the minutes of the meeting.</u> The Secretary shall maintain an attendance record for each meeting.
- (d) If a Board Member anticipates that they will not be able to attend a meeting, the Board Member shall provide advance written notice of absence to the Secretary at least twenty-four (24) hours prior to the meeting ("Requisite Notice"). If a Board Member is a Division Board Member, that Member may send a Division representative to participate in the Meeting in their absence, provided they give Requisite Notice.
- (e) <u>If a Board Member does not provide Requisite Notice, then the Secretary shall mark the Board Member as not having provided Requisite Notice for that meeting.</u>
- (f) If a Board Member, other than an Ex Officio Board Member, has two (2) absences without Requisite Notice, the Secretary shall notify the Board Member. After the Secretary provides such notification, if the Board Member has one (1) additional absence without Requisite Notice, then the Board may, by majority vote, remove the Board Member from the Board of Governors.
  - The Board Member being considered for removal shall be permitted to appear before the Board of Governors to address their lack of attendance.
- (g) <u>If a Board Member, other than an Ex Officio Member, has three (3) consecutive absences without Requisite Notice, the President may request the Board to reevaluate the Board Member's continued participation with the Board of Governors. After such reevaluation, the Board may, by majority vote, remove the Board Member from the Board of Governors.</u>
  - The Board Member being considered for removal shall be permitted to appear before the Board of Governors to address their lack of attendance.
- (h) If any Board Member misses nine (9) meetings during their term on the Board of Governors with or without Requisite Notice, the President may request the Board to reevaluate the Board Member's continued participation with the Board of Governors. After such reevaluation, the Board may, by majority vote, remove the Board Member from the Board of Governors.
  - The Board Member being considered for removal shall be permitted to appear before the Board of Governors to address their lack of attendance.
- (i) In addition to attending monthly Board of Governor Meetings, the Members of the Board shall attend ACBA Board dinners, receptions, Committee, Division and Section events and activities during their term of office.

#### Section 8.7 CONFLICTS OF INTEREST

Any member of the Board of Governors and the Executive Director, or any Deputy Director or Assistant Director, shall disclose any relationship which such person may have with any person, corporation, or other entity with whom or with which the Association proposes to enter into any contract or other transaction which will or may result in his or her financial gain or personal advantage. Such persons shall abstain from voting upon the execution of the proposed contract or other transaction. If any member of the Board of Governors shall fail to make such disclosure before the Association enters into such contract or transaction, the Board of Governors may demand such member's resignation from the Board of Governors.

A contract or other transaction between the Association and any member of its Board of Governors, its Executive Director, its Deputy Director or its Assistant Director (hereinafter in this Section 8.7 referred to as "Interested Parties"), or between the Association and any other corporation, partnership, joint venture, trust or other association in which any member of the Association's Interested Parties are governors or officers of the other association or have a financial or other interest, and are therefore considered "interested directors" is not void or voidable solely for that reason, or solely because any Interested Parties of the Association are present at or participate in the meeting of the Board of Governors that authorizes the contract or transaction, or solely because the vote of the Interested Parties is counted for that purpose, if:

- (1) the material facts to the relationship or interest and as to the contract or transaction are disclosed or are known to the Board of Governors and the Board of Governors authorizes the contract or transaction by the affirmative vote of a majority of the disinterested members of the Board Governors, even though the disinterested members of the Board of Governors are less than a quorum;
- (2) the material facts as to the relationship or interest or transaction are disclosed or are known to the Board of Governors entitled to vote thereon, if any, and the contract or transaction is specifically approved in good faith by a vote of those Board of Governors;
- (3) the contract or transaction is fair as to the Association as of the time it is authorized, approved or ratified by the Board of Governors;
- (4) the contract or transaction is between the Association and an association that is not wholly owned or controlled by the Association and the person who is a member of the Interested Parties is also a governor or officer of the other association, if:
- (i) one of the conditions herein above in subsections (1), (2) or (3) to this Section 8.7 are satisfied; or (where both (ii) and (iii) must apply)
- (ii) the Interested Parties do not participate personally and substantially in negotiating the transaction for either the Association or the other association; and
- (iii) if the transaction is approved by the Board of Governors or governors of either association, the person that is a member of the Board of Governors of each association does not cast a vote that would be necessary at a meeting to approve the transaction on behalf of either the Association or the other association; or
- (5) the contract or transaction is between the Association and an association that is wholly owned or controlled by the Association and the person who is also one of the Interested Parties is also a governor or officer of the other association and subsections (1), (2) or (3) to this Section 8.7 are satisfied.

Interested members of the Board of Governors may be counted when present at meetings of the Board of Directors or of such committee of the Board of Governors considering a contract or transaction for the purpose of determining the existence of quorum.

Notwithstanding the foregoing, the Corporation and the Interested Parties shall comply with any separate conflict of interest policy which has been adopted by the Association.

Notwithstanding the foregoing, the following shall also apply. A member of the Board of Governors shall abstain from voting upon the execution of the proposed contract or other transaction as described in this Section 8.7 which will or may result in his or her financial gain or personal advantage. If any member of the Board of Governors shall fail to make such disclosure as described in this Section 8.7 before the Association enters into such contract or transaction, the Board of Governors may demand such member's resignation from the Board of Governors. The Association and the Interested Parties shall comply with any separate conflict of interest policy which has been adopted by the Association.

#### Section 9.1. LIMITATION OF LIABILITY OF MEMBERS OF THE BOARD OF GOVERNORS OR OFFICERS

A member of the Board of Governors <u>or officers of the Association</u>, as such, shall not be personally liable for monetary damages for any action taken, or any failure to take any action, unless he or she has both:

- (a) breached or failed to perform the duties of his or her office under Subchapter B of Chapter 57 of the Pennsylvania Nonprofit Corporation Law of 1988, 15 Pa.CS. §§5711 5717; and,
- (b) the breach or failure to perform constituting self-dealing, willful misconduct, or recklessness.

The foregoing exemption from liability shall be retroactive to the fullest extent permitted by law. This exemption from liability shall not apply to the responsibility or liability of a member of the Board of Governors or officer of the Association pursuant to any criminal statute or the liability of a member of the Board of Governors or officer of the Association for the payment of taxes pursuant to federal, state, or local law. Any repeal or modification of this sub-section shall be prospective only, and shall not adversely affect any limitation on the personal liability of a member of the Board of Governors or officer of the Association existing at the time of such repeal or modification.

Recklessness, as defined in the laws of the Commonwealth of Pennsylvania, means a conscious disregard of substantial and unjustifiable risk and consideration of circumstances actually known to a member of the Board of Governors or officer of the Association making a decision on behalf of the Association. In order to be considered reckless, the conscious disregard in said decision-making must involve a gross deviation from the standard of conduct that a reasonable person would observe in the member of the Board of Governors or officer of the Association situation.

# Section 9.2. INDEMNIFICATION OF MEMBERS OF THE BOARD OF GOVERNORS, OFFICERS, AND OTHER INDEMIFIED REPRESENTSTIVES

(a) To the fullest extent possible under Sub-chapter D of Chapter 5,7 of the Pennsylvania Nonprofit Corporation Law of 1988, 15 Pa.CS. §\$5741 5750, the Association shall indemnify members of the Board of Governors, officers of the Association, employees of the Association and agents of the Association (hereinafter referred to in this Article 9 as an "Indemnified Representative") against any Liability incurred in connection with any proceeding in which the Indemnified Representative may be involved as a party or otherwise, by reason of the fact that such person is or was serving in an Indemnified Capacity, including without limitation, Liabilities resulting from any actual or alleged breach or neglect of duty, error, statement, misstatement or misleading statement, negligence, gross negligence, or act giving rise to strict or products liability, except where such indemnification is expressly prohibited by applicable law, or where the conduct of the Indemnified Representative has been determined to constitute willful misconduct or recklessness within the meaning of 15 Pa.C.S. § 5746(b) or any superseding provision of the law, sufficient in the circumstances to bar indemnification against Liabilities arising from the conduct.

#### Section 9.4. DENIAL OF RIGHT TO INDEMNIFICATION.

Indemnification, under Section 9.3 <u>9.2</u> of the By-Laws, shall be made by the Association unless a determination is reasonably and promptly made that indemnification of an Indemnified Representative is not proper in the circumstances because of grounds for denying indemnification under this Article or under applicable law. Such determination may be made only by the Board of Governors by a majority vote of a quorum consisting of members of the Board of Governors who were not parties to the Proceeding.

#### Section 9.5. EXPENSES.

Expenses (including attorneys' fees) incurred in defending any Proceeding referred to in Section 9.3 9.2 of the By-Laws may be paid by the Association in advance of the final disposition of the Proceeding upon receipt of an undertaking by or on behalf of the Indemnified Representative to repay the amount if it is ultimately determined that he or she is not entitled to be indemnified by the Association as authorized in this Article or otherwise. Notwithstanding any other provision of this Article, to the extent that an Indemnified Representative has been successful on the merits or otherwise in defense of any Proceeding referred to in Section 9.3-9.2 of the By-Laws, or in defense of any claim, issue or matter therein, he or she shall be indemnified against Liabilities actually and reasonably incurred by the Indemnified Representatives in connection therewith. The Association shall also make such other indemnifications as shall be required by statute.

#### Section 9.8. DISCHARGE OF DUTY

An Indemnified Representative shall be deemed to have discharged his or her duty to the Association if he or she acted in good faith, in a manner that such person reasonably believed to be in, or not opposed to, the best interests of the Corporation and, with respect to any criminal proceeding, had no reasonable cause to believe that such person's conduct was illegal. Additionally, to the extent not inconsistent with the Pennsylvania Nonprofit Corporation Law of 1988, an Indemnified Representative relied in good faith on information, opinions, reports or statements, including financial statements and other financial data, in each case prepared or presented by any of the following:

- (a) one or more officers or employees of the Association whom such Indemnified Representative reasonably believes to be reliable and competent with respect to the matters presented;
- (b) counsel, public accountants, or other persons as to matters which the Indemnified Representative reasonably believes to be within the professional or expert competence of such person; or
- (c) a committee of the Board of Governors on which he or she does not serve, duly designated in accordance with law, as to matters within its designated authority, which committee he or she reasonably believes to merit confidence.

### Section 9.10. SCOPE OF ARTICLE

The indemnification and advancement of expenses of Indemnified Representatives, as authorized by this Article and by Sub-chapter D of Chapter 57 of the Pennsylvania Nonprofit Corporation Law of 1988, 15 Pa.CS. §§5741-5750, shall not be deemed exclusive of any other rights to which those seeking indemnification or advancement of expenses may be entitled under any statute, agreement, vote of members of the Association or disinterested members of the Board of Governors or otherwise, both as to action in an official capacity and as to action in any other capacity. The indemnification and advancement of expenses provided by or granted pursuant to this Article shall continue as to a person who has ceased to be an Indemnified Representative and shall inure to the benefit of the heirs and personal representatives of that person. A right to indemnification or to advancement of expenses arising under a provision of the Articles of Incorporation or By-laws may not be eliminated or impaired by an amendment to or repeal of the provision after the occurrence of an act that is the subject of the threatened, pending or completed action or proceeding, whether civil, criminal, administrative or investigative, for which indemnification

or advancement of expenses is sought, unless the provision in effect at the time of the act explicitly authorizes the elimination or impairment after an act has occurred.

#### Section 10.1. CREATION OF COMMITTEES

The Association shall have the following standing committees: Amicus Curiae Brief Committee, (Article 11), Audit Committee, (Article 12), Finance Committee, (Article 13), Judiciary Committee, (Article 14), Membership Committee, (Article 15), Nominating Committee (Article 6), Professional Ethics Committee (Article 16) Access to Justice Committee (Article 17), and Unauthorized Practice of Law Committee (Article 18). In addition, it shall have such other standing and special committees as the Association or its Board of Governors may create from time to time. The duties and responsibilities of standing committees provided for in these By-Laws shall be as set forth in these By-Laws or in any amendments thereto. The duties and responsibilities of other standing and special committees shall be as set forth in the resolutions creating them and, in any amendment, thereof subsequently adopted by either the Association or its Board of Governors. Assignments to and projects of standing and special committees shall be made by the President. Any committee of the Association shall be subject to the limitations as set forth in the Pennsylvania Nonprofit Corporation Law of 1988.

#### Section 12.6. INDEMNIFICATION

To the fullest extent of the law and pursuant to Article 9 of the Allegheny County Bar Association's By-Laws, Indemnified Representatives, as defined in Article 9 shall include, for purposes of this Article 12, the Association shall indemnify the members of the Audit Committee, ("Indemnified Representatives") as of right against any actual or threatened civil, criminal, administrative action, suit or proceeding arising out of their service on the Audit Committee. Members of the Audit Committee shall be deemed to have discharged their duties if they relied in good faith on information, opinions, reports, or statements, including financial statements and other financial data prepared or presented by (a) officers or employees of the Association whom the Indemnified Representative members of the Audit Committee reasonably believes to be reliable and competent in the matters presented; or (b) counsel, certified public accountants or other persons whom the Indemnified Representative members of the Audit Committee reasonably believes to be reliable and competent as to the matters presented; or (c) another duly designated committee of the Board of Governors on which the member of the Audit Committee does not serve as to matters within its designated authority, which the member of the Audit Committee reasonably believes to merit confidence.
