On Tuesday, February 7, 2023, the Board of Governors of the Allegheny County Bar Association (ACBA) at its monthly meeting voted to amend the Bar Association By-Laws. A quorum of members of the Board was present for the Board Meeting. The vote of those present at the meeting to amend the By-Laws was unanimous.

In accordance with Article 21 of the ACBA By-Laws, the Board can amend the By-Laws by a vote of 2/3 of the members of the Board of Governors present and voting at any meeting in connection with which a quorum is present; provided that the results of the such vote shall be published in the *Pittsburgh Legal Journal* within ten (10) days of the aforesaid vote to amend, accompanied by a notice to members that the By-Laws, as amended, shall become effective within twenty (20) days of the date of such publication unless a petition is filed with the Association signed by fifty (50) active members in good standing requesting a vote of the membership on the subject amendment(s), or particular portion(s) thereof. Upon receipt of such petition, the matter shall be placed before the membership for a vote at the next annual meeting of the membership or at a meeting specially convened for that purpose.

Notice is hereby given that the By-Laws, as amended, shall become effective on Thursday, March 7, 2023, unless a petition is filed with the Association as herein above set forth.

#### BY-LAWS OF THE ALLEGHENY COUNTY BAR ASSOCIATION

#### ARTICLE 10 COMMITTEES

#### Section 10.1. CREATION OF COMMITTEES.

The Association shall have the following standing committees: Amicus Curiae Brief Committee, (Article 11), Audit Committee, (Article 12), Finance Committee, (Article 13), Judiciary Committee, (Article 14), Membership Committee, (Article 15), Nominating Committee (Article 6), Professional Ethics Committee (Article 16) **Public Service Access to Justice** Committee (Article 17), and Unauthorized Practice of Law Committee (Article 18). In addition, it shall have such other standing and special committees as the Association or its Board of Governors may create from time to time. The duties and responsibilities of standing committees provided for in these By-Laws shall be as set forth in these By-Laws or in any amendments thereto. The duties and responsibilities of other standing and special committees shall be as set forth in the resolutions creating them and, in any amendment, thereof subsequently adopted by either the Association or its Board of Governors. Assignments to and projects of standing and special committees shall be made by the President.

# ARTICLE 17 PUBLIC SERVICE ACCESS TO JUSTICE COMMITTEE

Section 17.1. NAME.

There shall be a committee known as the **Public Service** Access to Justice Committee, the members of which shall be appointed by the President of the Association.

Section 17.2. OFFICERS.

There shall be a Chair and Vice-Chair of the Committee, appointed by the President of the Association.

Section 17.3. PURPOSE.

The <u>Public Service Access to Justice</u> Committee shall promote and encourage the members of this Association to provide pro bono public services and assist them in fulfilling their professional and ethical responsibilities to provide such services through programs operated or administered by the Association or others to assist persons unable to afford necessary legal services. The Committee shall investigate and study the problems affecting the delivery of legal services to indigent persons and recommend action to resolve those problems. The Committee may also support public or private agencies or other organizations dedicated to providing legal services for those not otherwise able to afford them.
