1. Kevin M. Kraus is the Sheriff of Allegheny County, Pennsylvania.

- 2. On May 16, 2002, the Governor of the Commonwealth of Pennsylvania signed Act 47 of 2002, 42 P.S. § 21118.1, authorizing sheriffs of second-class counties to fix fees in an amount determined by the sheriff, subject to the approval of the President Judge of the Court of Common Pleas.
 - 3. Act 47 provides in pertinent part:
- (a) Establishment and modification of fees. In counties of the second class on or after the effective date of this section, the sheriff may establish, increase, decrease, modify or eliminate fees and charges used exclusively to offset existing costs with the approval of the president judge of the court of common pleas.
- 3. The various fees presently collected by the Sheriff were authorized by Order of President Judge Robert Kelly on the 16th day of September 2002, subsequently amended and authorized by Order of President Judge Joseph James on the 11th day of June 2004 and amended and authorized by Order of President Judge Kimberly Clark most recently in February of 2019.
- 3. The Sheriff Petitioned for an increase in several fees in 2019 for several fees that had not been previously adjusted.
- 4. In this Petition, the Sheriff is requesting the increase of one fee which has not been increased since 2017, that being the Service of Civil Process fee.
- 5. The Service of Civil Process fee increase addresses the increase employment costs of the civilian staff and sworn personnel who serve the papers. Wage increases and additional benefit costs have raised operational costs as have the increases in costs of office supplies, postage, and fuel costs.
- 6. The current Sheriffs Schedule of Fees and the proposed fees, including the itemization of apportionment between the County, Computerization Budget and the Sheriff Revenue Fund is below.
