The Nominating Committee of the Bar Association is seeking candidates for the positions of President-Elect. Secretary (two-year term), five (5) Governor positions (three-year terms). and eleven (11) Judiciary Committee positions (three-year terms). Terms are to begin on July 1, 2025.

Qualifications:

President-Elect: Candidate must be a member of the Bar Association and a current or former member of the Board of Governors of the Bar Association. One seat is available for a one-year term, with the individual automatically ascending to the position of President and, subsequently, Immediate Past-President.

Secretary: Candidate must be an Active Member of the Bar Association.

Governor: Candidate must be an Active Member of the Bar Association and should have a history of active participation in one or more Committees. Divisions or Sections of the ACBA. Five (5) seats are available for three (3) year terms.
