FOLLOWING THE CALL OF THE LIST, COUNSEL SHALL BE PREPARED TO CONCILIATE THE CASE BEFORE THE TRIAL JUDGE. PLEASE BRING AN ADDITIONAL COPY OF THE "VOIR DIRE STATEMENT" AND THE "PROPOSED ADDITIONAL VOIR DIRE" FOR THE TRIAL JUDGE.

Except for good cause shown or by agreement of counsel to the contrary, the date for completion of discovery contained in the notice of publication of this list will be interpreted to mean that discovery must be completed by such date. (7) If listed counsel is not available and substitute counsel is not provided, the case will proceed without counsel.

(8) When called to select a jury, counsel must appear within 30 minutes. If counsel is not present when called, a clerk will select the jury and the case will be ordered to trial without counsel.

(9) The trial policy rules will be applied regardless of the directions or desires of clients.

## ACBA BOARD OF GOVERNORS AMENDS BAR ASSOCIATION BY-LAWS

On Tuesday, November 5, 2024, the Board of Governors at its monthly meeting voted to amend the Bar Association By-Laws. A quorum of members of the Board was present for the Board Meeting. The vote of those present at the meeting to amend the By-Laws was unanimous.

In accordance with Article 21 of the ACBA By-Laws, the Board can amend the By-Laws by a vote of 2/3 of the members of the Board of Governors present and voting at any meeting in connection with which a quorum is present; provided that the results of the such vote shall be published in the Pittsburgh Legal Journal within ten (10) days of the aforesaid vote to amend, accompanied by a notice to members that the By-Laws, as amended, shall become effective within twenty (20) days of the date of such publication unless a petition is filed with the Association signed by fifty (50) active members in good standing requesting a vote of the membership on the subject amendment(s), or particular portion(s) thereof. Upon receipt of such petition, the matter shall be placed before the membership for a vote at the next annual meeting of the membership or at a meeting specially convened for that purpose.

Notice is hereby given that the By-Laws, as amended, shall become effective on Thursday, November 27, 2024, unless a petition is filed with the Association as herein above set forth.

## BY-LAWS OF THE ALLEGHENY COUNTY BAR ASSOCIATION

## Section 10.12 Bringing Other Matters to the Attention of the Board of Governors

Except as provided for in Sections 10.10 and 10.11, if a Committee desires to raise a question or concern to the Board of Governors, the following steps are to be taken:

(1) <u>The Committee shall adopt a resolution presenting a concise statement of the question or concern. The resolution shall, if appropriate, include information as to whether and for what reasons expedited disposition of the matter is requested.</u>

(2) <u>The Committee Chair shall submit the resolution to each member of the Executive Committee, and to the Executive Director.(3)</u> The President shall, after consultation with the Executive Committee, make a preliminary determination as to whether the matter is to be presented to the Board.

(3) If the President's preliminary determination is to decline to have the matter presented to the Board, the issue of whether the matter is to be presented to the Board shall promptly thereafter be brought to a vote by the Board.

(4) If presented to the Board, whether based upon the President's preliminary determination or based upon the vote of the Board, the question or concern shall be duly considered.

(6) The President shall promptly thereafter inform the Committee Chair submitting the resolution as to the status of the matter.

Section 19.8 Bringing Other Matters to the Attention of the Board of Governors

Except as provided for in Sections 19.6 and 19.7, if a Division desires to raise a question or concern to the Board of Governors, the following steps are to be taken:

(1) The Division shall adopt a resolution presenting a concise statement of the question or concern. The resolution shall, if appropriate, include information as to whether and for what reasons expedited disposition of the matter is requested.

(2) The Division Chair shall submit the resolution to each member of the Executive Committee, and to the Executive Director.

(3) The President shall, after consultation with the Executive Committee, make a preliminary determination as to whether the matter is to be presented to the Board.

(4) If the President's preliminary determination is to decline to have the matter presented to the Board, the issue of whether the matter is to be presented to the Board shall promptly thereafter be brought to a vote by the Board.

(5) If presented to the Board, whether based upon the President's preliminary determination or based upon the vote of the Board, the question or concern shall be duly considered.

(6) The President shall promptly thereafter inform the Division Chair submitting the resolution as to the status of the matter.

Section 20.9 Bringing Other Matters to the Attention of the Board of Governors

Except as provided for in Sections 20.6, 20.7 and 20.8, if a Section desires to raise a question or concern to the Board of Governors, the following steps are to be taken:

(1) The Section shall adopt a resolution presenting a concise statement of the question or concern. The resolution shall, if appropriate, include information as to whether and for what reasons expedited disposition of the matter is requested.

(2) The Section Chair shall submit the resolution to each member of the Executive Committee, and to the Executive Director.

(3) The President shall, after consultation with the Executive Committee, make a preliminary determination as to whether the matter is to be presented to the Board.

(4) If the President's preliminary determination is to decline to have the matter presented to the Board, the issue of whether the matter is to be presented to the Board shall promptly thereafter be brought to a vote by the Board.

(5) If presented to the Board, whether based upon the President's preliminary determination or based upon the vote of the Board, the question or concern shall be duly considered.

(6) The President shall promptly thereafter inform the Section Chair submitting the resolution as to the status of the matter.

Section 2.3 Bringing Matters to the Attention of the Board of Governors

If one or more Members desire to raise a question or concern to the Board of Governors, the following steps are to be taken:

(1) A petition shall be prepared and endorsed by at least twenty-five (25) Members. The petition shall present a concise statement of the question or concern. The petition shall, if appropriate, include information as to whether and for what reasons expedited disposition of the matter is requested.

(2) The petition shall be submitted to each member of the Executive Committee, and to the Executive Director.

(3) The President shall, after consultation with the Executive Committee, make a preliminary determination as to whether the matter is to be presented to the Board.

(4) If the President's preliminary determination is to decline to have the matter presented to the Board, the issue of whether the matter is to be presented to the Board shall promptly thereafter be brought to a vote by the Board.

(5) If presented to the Board, whether based upon the President's preliminary determination or based upon the vote of the Board, the question or concern shall be duly considered.

(6) The President shall promptly thereafter inform the petitioners as to the status of the matter.
