**NOTICE OF PROPOSED RULEMAKING**

**Proposed Recission and Replacement  
of Pa.R.Civ.P.M.D.J. 319**

The Minor Court Rules Committee is considering proposing to the Supreme Court of Pennsylvania the recission and replacement of Pa.R.Civ.P.M.D.J. 319, pertaining to the appearance of the parties at the civil hearing for the reasons set in the Publication Report. Pursuant to Pa.R.J.A. 103(a)(1), the proposal is being published in the *Pennsylvania Bulletin* for comments, suggestions, or objections prior to submission to the Supreme Court.
